**CLOSURE OF H SHARE REGISTER OF MEMBERS**

References are made to the results announcement for the year ended 31 December 2022 and the notice of 2022 annual general meeting (the “**AGM**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) dated 23 March 2023 and 25 April 2023, respectively, and the shareholders’ circular (the “**Circular**”), in which the annual profit distribution plan for 2022 of the Company (the “**Profit Distribution Plan**”) is disclosed.

According to the Profit Distribution Plan, in 2022, the net profit attributable to shareholders of the parent company in the audited consolidated statements of the Company is RMB2,294,116,322.38, and the undistributed profit is RMB7,823,373,780.42. The Company intends to use the total share capital of 4,187,093,073 shares as the base, being the total issued shares as of the date of board meeting approving the annual profit distribution plan for 2022, and distribute cash dividend (the “**Annual Dividend**”) of RMB1.93 (including tax) for every 10 shares, with the total cash dividend of RMB808,108,963.09. The balance of the undistributed profits of the Company will be carried forward to the next year. The Profit Distribution Plan is subject to the consideration and approval at the AGM to be convened by the Company on 16 May 2023.

If the Profit Distribution Plan is approved by the shareholders, the Annual Dividend will be distributed to H shareholders whose names appear on the H share register of members of the Company on Wednesday, 24 May 2023. The H share register of members of the Company will be closed, for the purpose of determining the entitlement of the H shareholders to receive the Annual Dividend, from Saturday, 20 May 2023 to Wednesday, 24 May 2023 (both days inclusive), during which period no transfer of H shares will be registered. H Shareholders who wish to receive the Annual Dividend but have not registered their share transfer documents shall lodge their transfer documents together with the relevant share certificates at the Company’s H Share Registrar, Computershare Hong Kong Investor Services Limited at Shops 1712-1716, 17/F, Hopewell Centre, 183 Queen’s Road East, Wan Chai, Hong Kong not later than 4:30 p.m. on Friday, 19 May 2023.

Further arrangements in respect of the distribution of the Annual Dividend will be announced by the Company in due course after the AGM.
