KEY OPERATING DATA OF NOVEMBER 2024

This announcement is made by China Suntien Green Energy Corporation Limited (the “**Company**”) pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

According to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for November 2024 amounted to 1,335,511.20 MWh, representing a year-on-year decrease of 18.44%. As at 30 November 2024, the accumulated power generation amounted to 12,374,461.71 MWh, representing a year-on-year decrease of 3.34%.

According to the Company's preliminary statistics, the transmission/sales volume of gas of the Group on a consolidated basis for November 2024 amounted to 343.2004 million cubic meters, representing a year-on-year decrease of 35.27%, of which, the sales volume of gas amounted to 273.6974 million cubic meters, representing a year-on-year decrease of 43.58%; the volume of gas transported by the Group for its clients amounted to 69.5030 million cubic meters, representing a year-on-year increase of 54.11%. As at 30 November 2024, the accumulated transmission/sales volume of gas amounted to 5,223.8827 million cubic meters, representing a year-on-year increase of 24.79%, of which, sales volume of gas amounted to 4,565.0893 million cubic meters, representing a year-on-year increase of 24.65%, the volume of gas transported by the Group for its clients amounted to 658.7934 million cubic meters, representing a year-on-year increase of 25.79%.
