### **KEY OPERATING DATA OF FEBRUARY 2025**

This announcement is made by China Suntien Green Energy Corporation Limited (the “**Company**”) pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

According to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) on a consolidated basis for February 2025 amounted to 1,420,962.90 MWh, representing a year-on-year increase of 35.18%. As at 28 February 2025, the accumulated power generation amounted to 2,930,097.87 MWh, representing a year-on-year increase of 14.74%.

According to the Company's preliminary statistics, the transmission/sales volume of gas of the Group on a consolidated basis for February 2025 amounted to 737.4987 million cubic meters, representing a year-on-year decrease of 0.14%, of which, the sales volume of gas amounted to 681.0665 million cubic meters, representing a year-on-year increase of 5.18%; the volume of gas transported by the Group for its clients amounted to 56.4322 million cubic meters, representing a year-on-year decrease of 38.03%. As at 28 February 2025, the accumulated transmission/sales volume of gas amounted to 1,414.5707 million cubic meters, representing a year-on-year decrease of 17.05%, of which, sales volume of gas amounted to 1,297.7750 million cubic meters, representing a year-on-year decrease of 14.55%; the volume of gas transported by the Group for its clients amounted to 116.7958 million cubic meters, representing a year-on-year decrease of 37.37%.
